The Winchester High on the Hog Barbecue contest committee, the Franklin County Kiwanis Club and our local major sponsors, The City of Winchester, The Herald Chronicle and Comcast are inviting you to help us celebrate our 25th year on April 20-21, 2012. Your participation is vital to make this the best contest ever.

As you will note on the application, the entry fee includes the four main categories as well as the two ancillary contests. Meat inspection will begin on Friday morning at 8am and hopefully be completed by the time of the cooks meeting. Also, please be sure to indicate a shirt size on the application.

Please note the following: Wampler's Sausage will again be providing each team with one pound of sausage to be cooked any way you choose for the Sausage competition. **All teams must enter the Sausage Competition.** Wampler's owner, Doug Young will be providing breakfast Saturday morning. Also, please note, sausage and Dessert is to be turned in in half pans that will be provided. You must be able to cover the pan with foil.

As in past years, the newspaper will be doing a special issue regarding the contest and the teams.

Please write a SHORT bio on the back of the application form, include such info as where you are from, how long you have been competing, awards won, family or friends. In the past, I have had to wing it on a few teams, hard to do if I don't know you.

If you will be bringing an RV, please indicate that on the entry form or if you will need a space larger than 30x30. Large RV spaces are limited and will be assigned on a first entry basis. Each team will be limited to one 20 amp circuit. This info will help with the layout and avoid problems on your arrival. We are limited to 54 teams so get your application in early.

Thursday night we will again have our sponsors' dinner at 6pm. Any teams arriving early are invited to join us. Friday and Saturday night entertainment is still to be determined. Saturday will include horseshoe pitching contest, Kids 4-H chicken Q. Also, as in the past several years, the carnival will be on site.

We are looking forward to the 2012, 25th annual Winchester High on the Hog Festival Tennessee State Championship. If there is anything we can do to make your participation a first class experience, please let us know. Without you, there is no contest. We hope to see you here.
